

## Presque Isle Downs

Rules and Conditions for Racing and Training ("Conditions")



- At all times, a horse must be in serviceable, sound racing condition in order to stable, race, work or train at PID. In the event any horse under Trainer's care enters a CDI facility and is not registered with HISA (for any reason, including, without limitation, that the horse is not required to be registered under HISA's rules because it has not yet had its first official timed and reported work), Trainer shall promptly, but in all cases within twenty-four (24) hours of such horse entering a CDI Facility, voluntarily register any such horse with HISA. The Trainer acknowledges that it is his/her obligation to (a) confirm the horse is in serviceable and sound racing condition, in order to stable, race, work or train on a Churchill Facility's grounds and (b) to inform the CDI Equine Medical Director or his/her authorized designee of any changes in the horse's fitness or health that would prevent a horse from stabling, racing, working or training on a Churchill Facility's grounds or any changes which would put Trainer, the Attending Veterinarian, or any horse in violation of these Conditions. Any horse that has not raced within 30 months since its last start shall be presumed unsound to stable, race, work, or train at PID unless approved in advance by the CDI Equine Medical Director. Any horse treated with extracorporeal shockwave therapy, radial pulse therapy, or similar treatments shall not race or work for a minimum of thirty (30) days following such treatment. Any horse six (6) years old or older that has never started shall be presumed unsound and ineligible to stable, race, work or train at any Churchill Facility unless approved in advance by the CDI Equine Medical Director or his/her authorized designee.
- Trainer will not enter in any race a horse that is a four-year old or older first time starter or a previously raced horse that has not raced in the 365 days preceding the date of the selected race UNLESS horse has completed an official work for the Pennsylvania State Horse Racing Commission ("Pennsylvania SHRC") prior to entry. Horses of 8 years of age or older as well as horses that have not raced within the one hundred fifty (150) days but have raced within the three hundred sixty-five (365) days preceding the date of the selected race must have an examination performed by Trainer's Attending Veterinarian to the satisfaction of the CDI Equine Medical Director prior to entry. Based upon this examination, the CDI Equine Medical Director, or his/her designee, may require the horse to work prior to being allowed to enter. If the horse is required to work it must meet the same requirements as a horse that is working off of the Pennsylvania SHRC's Veterinarian's List.
- 3. Any horse that finishes more than twelve (12) lengths behind the winner in their last five (5) consecutive starts, will be inelligible to start in a race at PID. Horses deemed ineligible under this rule may reestablish eligibility in another jurisdiction. Due to mitigating circumstances the owner or trainer of a horse deemed ineligible under this rule may be given one additional start to restore eligibility by appealing the ruling to the PID Racing Panel. All appeals must be requested and approved prior to entry. For the purposes of this rule, the Racing Panel shall be the Racing Secretary, a representative of the

- Horsemen's Group, the presiding State Steward and State Veterinarian, and the CDI Equine Medical Director. Horses granted eligibility under the appeal process will have one start to reestablish eligibility. This rule shall not prohibit the racing association from exercising its right to refuse the entry of any horse that the racing association deems uncompetitive and or unfit for racing.
- Trainer will not enter in a race any horse that has raced greater than four (4) times in the last fifty-six (56) days immediately preceding the race.
- 5. Under no circumstances shall an examination conducted by a veterinarian who has NOT been identified as the Trainer's Attending Veterinarian in compliance with these Conditions constitute a valid examination for purposes of determining a horse's fitness to race, work or train.
- PID and the CDI Equine Medical Director and his/her designee are entitled (but not obligated) to contact, without prior notice, Trainer's Attending Veterinarian to confirm that examinations have been conducted pursuant to these Conditions and that any such examination meets PID's requirements. PID and the CDI Equine Medical Director and his/her designee shall have the right (but not the obligation) to examine and review all records of examinations performed in accordance with these Conditions, and Trainer agrees that PID or the CDI Equine Medical Director may inspect and copy for each's own use, and Trainer shall provide upon request, all documents, electronic or otherwise, containing reports by official racing veterinarians of pre-race examinations, postrace examinations (including without limitation necropsy reports) and/or any records of procedures required by regulatory agencies or under applicable safety accreditation organizations of industry Trainer's horse(s) racing or training at PID.
- 7. All horses stabled or entered to race at PID, or that are on PID Grounds are subject to: (a) veterinary inspections and requests for veterinary medical records by the CDI Equine Medical Director, or his/her designee and (b) veterinary monitoring. Trainer, Trainer's staff, and Attending Veterinarians will cooperate fully with all requests made by CDI Veterinary Staff and PID Staff.
- As used herein, the term "Attending Veterinarian" shall include the undersigned veterinarian and any veterinarian who is a member of his/her veterinary practice.
- 9. If stabled on PID Grounds, both Trainer and the Attending Veterinarian will abide by all rules and regulations of PID, including, without limitation, House Rules (including those relating to equine welfare and integrity), or other rules (including, without limitation, all rules set forth in PID's Condition Book, Stall Application, the Rules of the Barn Area, and the Rules of the Track), all of which are hereby expressly incorporated by reference herein. Trainer and Attending Veterinarian shall be responsible for obtaining and becoming familiar with such rules and regulations.
- 10. All Pennsylvania SHRC licensees, including but not limited to PID owners, trainers, jockeys, and grooms ("licensees"), participating in stabling, racing, training, and related activities at PID recognize that hazards and risks inherent in such activities may cause the injury or death of horses. Therefore, in consideration of participating in stabling, racing, training, and related activities at CDI properties, all licensees assume the risks of, and

release, hold harmless and covenant not to sue all other licensees so participating for: (i) Ordinary negligence which causes or contributes to loss, loss of use, injury or damage to horses while on the premises of aforementioned CDI properties; and (ii) Ordinary negligence which causes or contributes to personal injury or property damage, including but not limited to loss, loss of use, injury or damage to horses arising from the use of grass fields or gallops owned or controlled by CDI properties, whether arising from alleged acts or omissions of a licensee and its agents or employees, the condition of the premises of aforementioned CDI properties or any other cause. Except as provided above, all licensees participating in racing, training, and related activities at CDI properties shall be responsible for their own acts and omissions and those of their agents and employees to the same extent as provided by law. The foregoing provisions shall be construed in a manner consistent with the limitations set forth herein to be as broad and inclusive as permitted by the laws of the State of Pennsylvania and the Pennsylvania SHRC's regulations and shall be binding upon Trainer, its successors and/or assignees. The maintenance by PID of insurance shall not affect the terms or interpretation of this Agreement. For purposes of this Agreement, PID shall mean and include each's officers, directors, agents, employees, contractors, servants and licensees. In the event of any inconsistency between these provisions and the Pennsylvania SHRC's regulations, the Pennsylvania SHRC's regulations shall control. Further, these provisions shall be deemed to be amended to the extent of, and to be in compliance with, any amendment to the Pennsylvania SHRC's regulations.

- 11. Both Trainer and Attending Veterinarian will abide by all rules and regulations of the Pennsylvania SHRC and the Horseracing Integrity and Safety Authority ("HISA") at any time expressly incorporated by reference herein, and the rules and regulations of the Pennsylvania SHRC or HISA, at any time adopted or as they may be amended (collectively, "SHRC or HISA Regulations"). Trainer and Attending Veterinarian shall be responsible for obtaining and becoming familiar with such rules and regulations.
- 12. Any failure by PID to enforce any terms or conditions of this Agreement shall not constitute a waiver by PID, and shall not affect or impair this Agreement in any way, or the right of CDI at any time to enforce this Agreement.
- 13. PID's approval or consent to any action proposed by Trainer or Attending Veterinarian shall not affect Trainer or Attending Veterinarian's obligation to strictly comply with this Agreement.
- 14. Both Trainer and the Attending Veterinarian understand and acknowledge that these Conditions shall be in effect annually commencing on the date of the opening of the PID stable area prior to the PID Race Meet (or any successor meet therefor) each year and continuing through the conclusion of the stabling period following the PID Race Meet (or any

successor meet therefor). For Trainers that have horse(s) on PID Grounds, these Conditions shall be in effect from earliest date noted above and for so long as Trainer has horse(s) on PID Grounds.

By signing below, <u>Trainer</u> acknowledges and agrees that Trainer (a) has read and fully understands the Conditions and agrees to be bound by them, (b) will consult with Trainer's Attending Veterinarian and the CDI Equine Medical Director if Trainer has any questions regarding such Conditions, and (c) will fully comply with the Conditions.

By signing below, the Attending Veterinarian acknowledges and agrees that he/she (a) is the Attending Veterinarian for the undersigned Trainer, (b) has read and fully understands the above Conditions and agrees to be bound by them, (c) will consult with the CDI Equine Medical Director if he/she has any questions regarding such Conditions, and (d) will comply fully with the Conditions.

Any change in the party that will be acting as the Trainer's Attending Veterinarian requires Trainer and the new Attending Veterinarian to submit a fully executed copy of these Conditions to CDI Equine Medical Director.

\*Provided however, that \$200 is the minimum purse distribution for Sixth place and below (the "Minimum Purse Distribution"). Accordingly, in the event the percentage of the purse to be distributed as listed above results in a distribution of less than \$250 for Sixth place and below, then the sum of \$250 shall be distributed to each such place in lieu of the percentage formula distribution.

## **EQUINE SAFETY INITIATIVES**

There have been several equine safety initiatives that have been implemented at Presque Isle Downs. Below are the changes and how they affect you.

- RULES AND CONDITIONS FOR RACING AND TRAINING AGREEMENT:
   This must be signed and submitted to the Stable Office upon arrival. This agreement will cover Presque Isle Downs and will be in effect until the end of the 2024 Presque Isle
- Downs Meet. Please make sure you and your veterinarian sign prior to turning it in.

  2. HISA REGISTRATION: All horses that enter PID grounds are to be registered with
  HISA (regardless of HISA rules i.e. no published work) within 24hrs of arrival.
- 3. MEDICATION-RESTRICTED RACES: Pursuant to HISA regulation all two (2) yearold races and stakes races will be conducted Lasix-free. Please consult with your veterinarian, Churchill Downs Incorporated Equine Medical Director (Dr. Farmer), or the Pennsylvania SHRC if you have any questions regarding this regulation.
- 4. SHOĆKWAVE THEŘAPY TRĚAŤMENTS: All prescribed shockwave treatments for horses stabled at a Churchill Downs Property MUST make a request to the CDI Equine Medical Director for a treatment to be administered at the trainer's barn NO LESS THAN 48hrs prior to treatment. FOLLOWING A SHOCKWAVE TREATMENT ALL HORSES ARE INELIGIBLE TO WORK OR RACE FOR 30 DAYS. Trainers violating this rule are subject to revocation of their stall privileges.
- 5. IN-TODAY SIGNAGE: All horses entered to race must be clearly identified starting at 7:30 a.m. on race day with an "In-Today" sign. Trainers should hang these signs on the stall door or adjacent to the stall. Additional Signs are available in the Racing Office

### 6. ENTRY RESTRICTIONS:

### A) Age Restrictions:

- All 4-year old and older first time starters and any previously raced horse that has not raced in the previous 365 days must contact the KHRC veterinarians to schedule an official veterinary work PRIOR to entry.
- Any horse six (6) years or older that has never raced is ineligible to stable, train or race at any Churchill Downs Property.
- No Horses 13 years or older are eligible to race, train or stable at PID without prior approval from The CDI Medical Director

### B) Lay-Offs:

- 1) The CDI Equine Medical Director may require evaluation(s) of any horse that has not raced within the one hundred fifty (150) days but have raced within the three hundred sixty-five (365) days preceding the date of the selected race. Any previously raced horse that has not raced in the previous 30 months is ineligible to train or race at any Churchill Downs Property, unless approved in advance by the CD Equine Medical Director.
- C) Poor Performance: Horses that are beaten by twelve (12) or more lengths in five consecutive starts will be ineligible to race at any Churchill Downs Property until approved by the Equine Medical Director to return.
- D) Restricted Number of Starts: Horses will be limited to four starts in a rolling eight-week period.
- 7. WAIVER CLAIMING RULE: Allows a trainer to enter a claiming race, but be ineligible to be claimed providing the horse has not started for a minimum of 120 days since its last race, and the horse is entered for a claiming price equal to or greater than the price at which it last started.

## THIRD PARTY LASIX

At Presque Isle Downs, Inc. (PIDI), race day administration of Lasix may only be administered in accordance with the Pennsylvania State Horse Racing Commission (PSHRC) directive by a third party service provider, at PIDI it will be Dr. McFarlin.

Dr. McFarlin ensures that the Lasix will be adminstered at all times consistent with the time frame, dosages, and other requirements of the PSHRC. Dr. McFarlin is licensed and in good standing with the Commission.

Dr. McFarlin will prepare proper documentation on the daily administration of Lasix and provide a copy of such documentation to PIDI and the PSHRC as required. The cost is \$25 per horse, with the payment billed directly out of the Horsemen Accounts.

For horses stabled on the grounds, Lasix is administered at the horse's current stall location and the trainer or an agent of the trainer must be with the horse at the time of administration. "In Today" signage will be posted on the stall doors of horses once they are treated.

Horses shipping in to race are required to arrive to the receiving barn 30 minutes prior to the treatment deadlines, and upon arrival, the trainer or an agent of the trainer must stay with the horse and be present at the time of treatment.

No private practitioners are allowed in the horse's stalls after the administration of Lasix on race day.

Procedures may be updated from time to time at the direction of the PSHRC.

Per HISA regulations, two-year olds or horses participating in any race classified as a Stakes race shall be ineligible to receive furosemide (i.e., Lasix, Salix) on race day.

<sup>\*</sup> Shippers are required to arrive thirty (30) minutes prior to Treatment Deadline.

## POLICIES & REGULATIONS

All trainers will cooperate with the Racing Secretary and/or the Stall Superintendent in the moving of horses for consolidation purposes of the backside in order to utilize the stabling facilities to the fullest extent.

Positively NO DOGS or OTHER ANIMALS are permitted on grounds.

No bedding other than straw is permitted.

No yearlings are permitted on the grounds at any time.

Substitute races will be used at the discretion of the Racing Secretary.

Owners and Trainers are advised that unless delinquent Jocks mounts are satisfied, Foal Papers will not be released.

The Pennsylvania Racing Commission has prohibited the use of turned down or any bent shoe at all Pennsylvania tracks.

Trainers and authorized agents, when entering horses, are solely responsible for claiming Registered PA Bred Preference in the event such preference is not declared at time of entry, such preference shall be forfeited.

Registered PA Breds will have preferred starter status in all non-restricted overnight races. Except a maiden is not preferred in a winners' race.

Presque Isle Downs & Casino will not be responsible for Foal Papers left in the Racing Office at the close of the meet.

Only the Trainer will be allowed to sign out Foal Papersfrom his/her file.

All horsemen are reminded to dress in appropriate attire in the paddock. No shorts or tank tops.

At the discretion of the Stewards or the Racing Association and without notice, the entries of any person or transfer of any horse may be refused.

The Pennsylvania State Horse racing Commission requires all owners and trainers to be licensed before they can start a horse.

HISA Regulation 2143 - Racehorse Monitoring:(a) All Horses, including stable ponies, entering the Racetrack grounds must have proof of health certificate and required vaccinations, which shall include: (1) Certificate of veterinary inspection within the prior 5 days or fewer days if high risk situations dictate; (2) Verification of EEE/WEE/WNV (encephalitides), rabies, and tetanus vaccinations within the prior 12 months; (3) Verification of Influenza and Rhinopneumonitis vaccinations within the prior 180 days or fewer days if high risk situations dictate; and (4) Verification of Negative Equine Infectious Anemia (Coggins) Test within the calendar year or in a shorter period of time if high risk situations dictate. (b) Each Racetrack shall submit the following information to the Authority with respect to each Horse on its grounds: (1) Horse identification; (2) Origin of Horse; (3) Date of entry; (4) Verification of certificate of veterinary inspection; and (5) Verification of vaccinations. (c) Each Racetrack shall submit the following information to the Authority with respect to each Horse leaving its grounds: (1) Horse identification; (2) Intended destination; (3) Reason for departure; (4) Date of exit; (5) Vehicle license plate; and (6) Transporter. (d) Horses moving interstate must meet the entry requirements of the destination State, the State Racing Commission in the destination State, and the individual Racetracks or Training Facilities to which the horse is being shipped in the destination State.

Horsemen will be allotted stalls with the understanding that their horses are ready to run. Presque Isle Downs & Casino reserves the right to ask horsemen to leave the property, after a period of inactivity, if they do not enter their horses in races that are available.

Prior approval must be obtained from the Racing Secretary or Stall Superintendent for any trainer requesting additional stall space for any horse or horses purchased through private sales, claims or trainer transfers. This must be done before and NOT after, to receive any consideration.

Each trainer shall register with the Racing Secretary all horses in his charge giving the name, age, sex, breeding and ownership of each. Any horse stabled on the grounds of the association without having been so registered, or occupying a stall not assigned to him, unless by special permission, will be cause for disciplinary action.

Foal Papers for all horses stabled on grounds must be registered with the Racing Secretary's Office.

Presque Isle Downs & Casino reserves the right to refuse any entry based upon poor performance.

It is the responsibility of the trainer to report the castration of any horse in their care to the State Veterinarian and to report such castration at time of entry of such

Presque Isle Downs & Casino also reserves the right to refuse admittance to or reject anyone whose presence it considers not to be in the best interest of racing (undesirable) in accordance with regulations of the Pennsylvania Horse Racing Commission.

Owners and trainers will be held responsible for the conduct of their employees while on the premises. All trainers and their employees must be finger-printed and shall at all times have their picture ID Badges visibly displayed at all times in all restricted areas, including while in the Test Barn. Failure to comply shall result in a hearing with potential of a fine and suspension.

## POLICIES & REGULATIONS CONTINUED

It is hereby agreed that Presque Isle Downs & Casino shall NOT be liable for, and that the owner and/or lessees of the horse will indemnify and hold harmless Presque Isle Downs & Casino against all responsibility, liability or claim of injury or damage to any person, horse or other property of the undersigned, or of any other person, or his or their agents, employees or associates, caused by the horse, or agent of the employees of the undersigned, or by any other person, *including employees, agents of Presque Isle Downs & Casino*, whether by negligence or otherwise, on the premises of PresqueIsle Downs & Casino.

All trainers shall carry compensation insurance covering all of their employees. This paragraph is intended to include all individuals employed by trainers in the training and racing of horses. All concessionaires shall carry compensation insurance covering all their employees.

All common areas and shedrows to the middle of roads will be subject to inspection by management or Stall Superintendent. All areas are to be raked and cleaned.

Eligibility, penalties and allowances of weights for all races, along with preference to the highest earners, will be determined after considering the reports, records and statistics published by Equibase and other racing statistical publications, but responsibility for weight carried and eligibility still remain with the owner and trainer as prescribed by the Rules of Racing.

When a race is in dispute, both the horse that finished first and any other horse involved in the dispute are subject to all penalties attached to the winner of that race until the matter is decided.

If any applicant has in his charge any horse whose name appears on any barred list (veterinarian, starter, steward's or any other barred list at any track), such applicant shall report the name of such horses and the fact that he has been so barred to the Racing Secretary at any meeting within Pennsylvania at which he proposes to enter such horse to race.

All changes in trainers must be reported to the Pennsylvania Horse Racing Commission and the Racing Secretary immediately along with the owner's and previous trainers authorization. Presque Isle Downs & Casino reserves the right to decline stall

Presque Isle Downs & Casino reserves the right to decline stall space to any owner or trainer. The removal of any dead horse is at the expense of the HBPA.

Although the Racing Office will assist by all means possible, Trainers are responsible for Eligibility, Weight Allowances, Preference Dates, Coggins and Workouts. In addition, Trainers must make sure that the name of the correct owner is written on Foal Papers.

Entries and declarations shall be made in writing and signed by the trainer of the horse, or his authorized agent, or some person deputized by him.

In all races except handicaps and races where the conditions expressly state to the contrary, fillies two (2) years old are allowed three (3) pounds, and fillies and mares three (3) years old and upward are allowed five (5) pounds before the 1st of September and three (3) pounds afterwards.

If a race is declared off, the Racing Secretary may split or divide any overnight race which may have closed and cause a new drawing for post positions.

Horses penalized in a race shall not be entitled to any allowances in that race.

Horses not entitled to the first allowance in a race shall not be entitled to the second, and if not the second to no subsequent allowances.

Winner or non-winner of a stated sum means winner or non-winner of a single race of that value to first horse.

### RECEIVING BARN RULES

- No Trainer competing on consecutive days may bring more horses than those which are for that day's race card, unless prior arrangements have been made with the Stall Superintendent.
- Trainers competing on consecutive days are responsible for additional bedding, and cleaning of stalls assigned to them (authorized bedding only).
- 3. Horses in for work & go must be out of the Receiving Barn by 9:30 a.m. Sunday thru Friday. Notraining on Saturday.
- Once a stall has been assigned, and a horse has occupied the stall, no changing/switching of stalls will be permitted.
- There will be no lending of Receiving Barn Tools, unless Receiving Barn personnel are present while tools are being used.
- 6. Only Receiving Barn personnel are permitted in the Barn Office, and no loitering around Barn Office.
- Trainers if there are any problems with the stalls please notify the Barn personnel.
- Trainers, when arriving at the Receiving Barn (report in) to the Barn Guard for stall allotments during Racing Days and the Stable Gate for Non-Race Days.
- 9. No Ponies in the Receiving Barn unless prior arrangements have been made.
- Trainers while assigned stalls in the Receiving Barn, the stalls and area around the stalls are to be policed of trash at all times.
- No dumping of ice/water buckets inside the stalls, contents are to be disposed of properly.

### CLAIMING RULES

Eligible to Claim:

- 1. Licensed as an owner in the state of PA
- A new owner who has not held an Owner's License in a racing jurisdiction during the prior year may claim by obtaining an Open Claiming License from the Commission.

(See Rule 305.402).

All claims must be made in writing on forms and in envelopes furnished by the Association and approved by the Commission. Both forms and envelopes must be filled out completely, and must be substantially accurate, otherwise the claim will be void. The determination of what is substantially accurate is within the sole discretion of the Stewards. Notwithstandingnd designation of sex or age on the racing program or any racing publication, claimant is solely responsible for determining the age or sex of a horse claimed, prior to depositing the claim form. All claims must be deposited in the Claiming Box at least ten (10) minutes before post time of the race with respect to which the claim is made.

305.407 Starting of a claimedhorse. For a period of 20 days after the claim, a claimed horse shall not start in a race in which determined eligibility price is less the 25% more than the price at which it was claimed. The claim day shall not count, but the following calendar day shall be the first day and the horse shall be entitled to enter whenever necessary so the horse may start on the 21st calendar day following the claim for any claiming price. This provision shall not apply to starter handicaps in which the weight to be carried is assigned by the handicapper.

**305.405** Sale or transfer of a daimed horse. When a horse is claimed, it shall not be sold or transferred to anyone wholly or in part except in a claiming race, for a period of 30 days from the date of claim, nor shall it, unless reclaimed, remain in the same stable or under control or management of its former owner or trainer for a like period. Further, it shall not race elsewhere until the end of the race season in progress or for period of 60 days, whichever shall first occur. The Commission shall have the authority to waive this rule upon application and demonstration that such waiver is in the best interest of horse racing in the Commonwealth of Pennsylvania. Nothing in this rule shall preclude any claimed horse from entering in any non-claiming stake race.

## Presque Isle Downs & Casino FOAL PAPER / DATE PREFERENCE SYSTEM

The Foal Paper/Date Preference System will be used at Presque Isle Downs & Casino as described below. Trainers are responsible for Dates - Preference Dates must be claimed at time of entry. A horse can have only one (1) Preference Date (Except for Z-Dates or where mentioned in Race Headings).

### 1. Dates assigned will be of three types:

1-DATE: An "0" Date will be assigned to a horse whose foal papers are submitted to the racing office prior to the first day that entries are taken. Thereafter, an E-Date will be assigned when foal papers are deposited with the Racing Office. Foal Papers MUST BE TURNED IN TO THE RACING OFFICE BY 3:00 P.M. TUESDAY, MAY 14, 2024, to receive an "0" DATE.

**E-DATE:** Foal papers turned into the Racing Secretary's Office will receive an entry date for that day, if not coming off a scratch. Also, an E-Date (the day that you're entering for) will be given to any horse entered into any Condition Book race. And, any horse running elsewhere after obtaining this date will lose their Preference Date. It is the trainer's responsibility to notify the Racing Office in such instances.

**R-DATE**: Horses which are drawn into races, and horses on the ALSO ELIGIBLE LIST which draw in to races, will receive a RUNNING DATE corresponding to the date on which they are to run.

**S-DATE**: Date on which a horse is scratched from a race. When horses have the same date: E-Dates have preference over R-Dates, and R-Dates have prefer-ence over S-Dates.

- In over-filled races, preference will be given to horses in the order of their assigned preference dates, earliest date first. Horses having identical dates will be chosen by lot, however, where ENTRY and RUNNING DATES are the same, the horse with the ENTRY DATE will have preference.
- Horse with dates established which re-enter, but do not get in, will keep the date previously established.
- Horse on the ALSO ELIGIBLE LIST shall be permitted to draw into races in the order of their dates.
- A horse on the ALSO ELIGIBLE LIST will lose its date if a scratch card is submitted and its number drawn.
- 6. Any horse which has drawn or obtained a position in a race and enters again on the next day that entries are taken shall be termed an in-today horse and if the race in which the horse is entered overfills, the horse shall be given no consideration whatsoever with the exception of participation in a stakes race.
- A horse which is a scheduled starter in a cancelled race will receive a Z-DATE, and will have preference the next time it is re-entered, unless the foal papers are signed out or the horse runs at another track.
- Not more than one horse owned by the same person shall be drawn into any overnight race to the exclusion of a single interest. Any trainer entering two horses in an overnight race must prefer the horse with the best date.
- 9. Horse on the VET'S, STEWARD'S, STARTER'S or PADDOCK JUDGE'S LIST cannot re-enter until removed from such list.
- 10. Preference dates are transferred through changes in ownership and changes in trainer only after the proper transfer procedures have been completed through the Steward's Office and delivered to the Racing Secretary's Office.
- 11. Preference dates are good for any type of race or distance with the exception of Stakes and Handicaps, or where superseded by *I-Dates* or Preference Clauses in race headings. Preference clauses in race headings will supersede *I-Dates*. (In instance of office error, Preference will be determined at the discretion of the Racing Secretary.
- Preference dates will not Supercede race conditions or Preference on any race such as; condition eligibility, winner's preference, PA bred preference or any other race condition or preference written for any race.
- 13. Foal Papers must be turned into the Racing Secretary's Office no later than 11:00 A.M. on the mornings that entries are being taken, to receive any consideration for *E-DATES* for that day's draw of entries.
- 14. Should a horse's papers be withdrawn from the Racing Office for just cause (i.e., tattooing, corrections, change of ownership or clarification, etc.), the Racing Secretary may determine the status of the Preference Date established.
- 15. You will lose your date when the Foal Papers are signed out of the Racing Office.

## **DIGITAL TATTOO**

On January 1, 2020, Race Horse Identification transitioned from lip tattooing to utilizing the Digital Tattoo (Picture Horse ID), which is accessible through scanning of the Jockey Club - issued microchip that has been implanted in the horse's neck by the breeder.

The process will be as follows:

- All foals of 2017 and forward must be micro-chipped before the Jockey Club will register the horse.
- Foals of 2016 and older who are not tattooed and who currently do not have a microchip (by January 1, 2020) will need to contact the Jockey Club (800-444-8521) to obtain a microchip. The Jockey Club issued microchip must be inserted into the horse and listed on the foal papers before the horse is digitally tattooed prior to its first race.
- TRPB Identifiers will come to your barn, scan the microchip to pull
  up the digital copy of the foal papers and verify the markings prior
  to you being allowed to race. Additionally, the TRPB Identifiers will
  take a series of photographs of your horse.
- The TRPB identification fee will remain the same: \$106.

## REMOVAL FROM VET'S LIST PROTOCOL

Regulatory Veterinarians may remove Horses from the Veterinarians' List in accordance with Rule 2242 and shall document such removal to the Authority. (a) A Horse placed on the Veterinarians' List as unsound or suffering from Epistaxis may be removed from the Veterinarians' List upon satisfaction of paragraphs (1) through (3) below. (1) A trainer must apply to the Regulatory Veterinarian for permission to work the Horse for removal from Veterinarians' List. Upon receiving such approval, the Trainer and Attending Veterinarian must observe the Horse jog and submit to the Regulatory Veterinarian a co-signed statement that the Horse is fit to perform a Workout. (2) The Horse must perform a Workout under the supervision of the Regulatory Veterinarian and demonstrate to the satisfaction of the Regulatory Veterinarian that the Horse is sound to race. (3) The Regulatory Veterinarian determines there is no evidence or signs of Epistaxis, physical distress, medical compromise, unsoundness, or lameness within1 hour after the Workout conducted pursuant to paragraph (a)(2) above. (b) A Horse placed on the Veterinarians' List as physically distressed or medically compromised may be removed from the Veterinarians' List provided sound health has been declared by the Attending Veterinarian or demonstrated to the Regulatory Veterinarian and documented to the Authority. (c) In addition to the requirements set forth herein and any requirements of the Protocol, if a Horse is placed on the Veterinarians' List for a positive test or overage of a primary substance invoking a mandatory stand down time, a positive Out-of-Competition test, or any other veterinary administrative withdrawal, the Horse shall be prohibited from entering a Race and may be released from the Veterinarians' List only after also undergoing a post Workout inspect

### HISA HEALTH, SAFETY AND ANTI-DOPING GUIDELINES

Presque Isle Downs encourages all horsemen to familiarize themselves with the Horseracing Integrity and Welfare Unit (HIWU) Anti-Doping and Medication Control (ADMC) guidelines that took effect on May 22, 2023. Please go to hisaus.org/regulations for the ADMC guidelines.

<u>HISA COVERED HORSE REGISTRATION</u> All horses must be registered with HISA as a Covered Horse upon completion of their first Timed and Reported Workout.

### **EQUINE SAFETY - HOUSE RULES**

Horses are ineligible to record a high-speed work within 7 days of placement on the Veterinarians' List for any reason.

For the 2024 PID meet we will be requiring a private veterinary examination, where at minimum the horse is jogged for the veterinarian, **PRIOR** to being eligible to enter for the following classification of horses:

- 1) All first time starters age 5 yrs. old and older
- 2) All horses that have previously raced, but have not raced in the previous 365 days.
- 3) All horses age 8 yrs old and older a. 8 yrs. old and older horses will only need an exam prior to making their first start of the meet. Subsequent starts will not require an exam unless the horse is placed on the Stewards List for poor performance or as required by the state veterinarian.

These examinations will be turned (either hard copy or electronically) into the racing office and need to be on file **PRIOR** to entry. Any previously-raced horse that has not raced in the previous 30 months is ineligible to train or race at any CDI property unless approved in advance by the CDI Equine Medical Director.

## PID WORKOUT RULES

<u>WORKOUTS (SOP)</u>: The following Recommendations are covered under the existing Commission's regulations as interpreted by the Board of Stewards.

- First-time starters will need 3 published works to start in a race: 1 published work must be from the gate; 1 published work must be at least a half-mile within 30 days of entry. First-time starters must have a gate card on file prior to entry time. (7 Pa. Code §305.243 (11) and 305.254)
- If a horse has not run in 45 days, it must have a one-half mile published work. (§305.243 (11)).
- If a horse has not run in 90 days, the horse needs 2 published works: 1 published work of at least one-half mile and another within 45 days of running.
- A 2-year-old horse must have 3 published works to start in a race, 1 of which must be from the gate with gate approval. (7 Pa. Code §305.243 (9)).
- Trainers are required to inform the clocker of the name and identity of a horse that is going to work. Failure to report to the clocker shall result in a fine and/or suspension. (7 Pa. Code §305.255)

## **USE OF RIDING CROP - LIMITATION:**

HISA Regulation 2281 - Riding Crop Specifications:

(a) Riding crops are subject to inspection by the Safety Officer, stewards, and the clerk of the scales. (b) All riding crops must be softpadded. (c) Riding crops shall have a shaft and a smooth foam cylinder and must conform to the following dimensions and construction: (1) The maximum allowable weight shall be 8 ounces; (2) The maximum allowable length, including the smooth foam cylinder attachment, shall be 30 inches; (3) The minimum diameter of the shaft shall be three-eighths of one inch; and (4) The shaft, beyond the grip, must be smooth, with no protrusions or raised surface, and covered by shock absorbing material that gives a compression factor of at least one millimeter throughout its circumference. (5) There shall be no binding within 7 inches of the end of the shaft. (6) The smooth foam cylinder is the only allowable attachment to the shaft and must meet the following specifications: (i) Shall have no reinforcements; (ii) Shall have a maximum length beyond the shaft of one inch; (iii) Shall have a minimum diameter of 0.8 inches and a maximum width of 1.6 inches: (iv) There shall be no other reinforcements or additions beyond the end of the shaft; (v) Shall be made of shock absorbing material with a compression factor of at least 5 millimeters throughout its circumference; (vi) Shall be made of a waterproof, ultraviolet, and chemical resistant foam material that is durable and preserves its shock absorption in use under all conditions; and (vii) Shall be replaced after reasonable wear and tear is visibly evident. (7) Riding crops shall not be altered and shall have an appropriate label or marking designating that the riding crop meets the required standards as established by the Authority. HISA Regulation 2282 - Riding Crop Violations and Penalties (a) Violations of Rule 2280 shall be categorized as follows. with the exception that use of the crop for the safety of Horse and rider shall not count toward the total crop uses: (1) Class 3 Violation—1 to 3 strikes over the limit. (2) Class 2 Violation—4 to 9 strikes over the limit. (3) Class 1 Violation—10 or more strikes over the limit. (b) Unless the stewards determine the merits of an individual case warrant consideration of an aggravating or mitigating factor, the penalties for violations are as follows: (1) Class 3 Violation— (i) \$250 or 10% of Jockey's portion of the purse, whichever is greater; (ii) Minimum 1-day suspension for the Jockey; and (iii) 3 points; (2) Class 2 Violation— (i) \$500 or 20% of Jockey's portion of the purse, whichever is greater; (ii) Horse disqualified from purse earnings, (iii) Minimum 3-day suspension for the Jockey; and (iv) 5 points; (3) Class 1 Violation— (i) \$750 fine or 30% of Jockey's portion of the purse, whichever is greater, (ii) Horse disqualified from purse earnings, (iii) Minimum 5-day suspension for the Jockey; (iv) 10 points. HISA Regulation 2283 - Multiple Violations (a) Stewards shall submit violations of Rule 2282 to the Authority to identify when multiple violations warrant additional suspensions consistent with the following schedule: (1) 11-15 points: 7 days. (2) 16-20 points: 15 days. (3) 21 or more points: 30 days. (b) Points assigned under Rule 2282 shall expire according to the following schedule: (1) Class 3 Violation: 6 months. (2) Class 2 Violation: 9 months. (3) Class 1 Violation: 1 year. (c) For purposes of paragraph (b), points are expunded from the date of final adjudication of the violation and not from the date of the violation. Mandatory suspensions are based on points accumulated for multiple violations and do not apply to single violations.

## ELIGIBILITY RULE UPDATE

Effective March 1, 2022

## Poor Performance Ineligibility Rule

- Any horse that finishes more than twelve (12) lengths behind the winner in their last five (5) consecutive starts, after February 28, 2022, will be ineligible to start in a race at Presque Isle Downs.
- Horses deemed ineligible under this rule may reestablish eligibility in another jurisdiction.
- Due to mitigating circumstances the owner or trainer of a horse deemed ineligible under this rule may be given one additional start to restore eligibility by appealing the ruling to the Racing Panel at the track the horse was deemed ineligible. All appeals must be requested and approved prior to entry. For the purposes of this rule, the Racing Panel shall be the Racing Secretary, a representative of the Horsemen's Group, the presiding State Steward, State Veterinarian and CDI Medical Director.
- Horses granted eligibility under the appeal process will have one start to reestablish eligibility.
- This rule shall not prohibit the racing association from exercising its right to refuse the entry of any horse that the racing association deems uncompetitive and or unfit for racing.

**RESTRICTED NUMBER OF STARTS:** Horses will be limited to four starts in a rolling eight week period (56 Days). Please direct any questions to the Racing Office.

### HISA Regulation 2262: (Void Claim Rule)

(a) Except as provided in paragraphs (e) and (g), title to a Covered Horse which is claimed shall be vested in the successful claimant from the time the field has been dispatched from the starting gate and the Covered Horse becomes a starter. (b) All claimed Covered Horses shall go to the Test Barn, or, if approved by the Authority, the secured area used for claimed Covered Horse inspections, for observation by the Regulatory Veterinarian. (c) Test Barn or approved secured area observation: (1) upon entry into the Test Barn or approved secured area, a claimed Covered Horse shall be periodically observed for no less than 30 minutes during the ``cooling out" process, unless excused by the Regulatory Veterinarian. (2) a claimed Covered Horse shall be observed by the Regulatory Veterinarian at the completion of any required sample collection, or immediately before the Covered Horse is released from the Test Barn or approved secured area, to determine whether the claimed Covered Horse will be placed on the Veterinarians' List for Epistaxis, or as unsound or lame. (3) the minimum criteria for observation by the Regulatory Veterinarian are: (i) to assess the claimed Covered Horse for signs of Epistaxis or any other concerning clinical abnormalities: and (ii) to jog the claimed Covered Horse in hand in a straight line of not fewer than 5 strides moving toward and away from the Regulatory Veterinarian. (d) If a claimed Covered Horse is placed on the Veterinarians' List for Epistaxis, or as unsound or lame, it is the responsibility of the Regulatory Veterinarian to notify the Stewards immediately so that the Stewards may order the Claim voided. (e) The Claim shall be voided, and ownership of the Covered Horse retained by the original Owner, if: (1) the Covered Horse dies or is euthanized before the Covered Horse is released to the claimant; (2) the Covered Horse is vanned off of the racing track and placed on the Veterinarians' List for Epistaxis, or as unsound or lame; or (3) the Regulatory Veterinarian determines pursuant to the observation described in Rule 2262(c)(1) that the Covered Horse will be placed on the 85 Web: www.hisaus.org 401 W. Main St. Suite 222 Lexington, KY, 40507 Veterinarians' List for Epistaxis, or as unsound or lame before the Covered Horse is released to the successful claimant. (f) The Claim shall not be voided if, prior to the Race in which the Covered Horse is claimed, the claimant elects to claim the Covered Horse by checking the appropriate box on the claim slip regardless of whether the Regulatory Veterinarian determines the Covered Horse will be placed on the Veterinarians' List for Epistaxis or as unsound or lame. (g) Notwithstanding Rule 3060(a) and 3070(c), and subject to Rule 2262(h), if a postrace sample collected from a claimed Covered Horse on the day of the Claim results in an Adverse Analytical Finding, the claimant shall be promptly notified by the Agency or the Authority and the claimant shall have the option to void the claim. The claimant shall have 48 hours from notification of the Adverse Analytical Finding to void the claim by submitting in writing to the Stewards the claimant's decision to void the claim. If the claimant chooses to void the Claim: (1) the claimant shall be entitled to the return from the prior Owner of all sums paid for the claimed Covered Horse; (2) the claimant shall be entitled, upon submission of expense records, to recoup reasonable expenses from the prior Owner related to the care, custody and control of the Covered Horse incurred after the date of the claim; and (3) the claimed Covered Horse shall be returned to the prior Owner. (h) A claimant shall not have the option to void a Claim pursuant to Rule 2262(g) if any of the following events have occurred since the Claim: (1) the claimed Covered Horse has made a start in a Covered Horserace or race; (2) the claimant failed to exercise due care in maintaining and boarding the claimed Covered Horse; (3) the claimant made material alterations to the claimed Covered Horse; or (4) the claimed Covered Horse dies or is euthanized.

Ban on Horse Slaughter: Any owner or trainer who directly or indirectly participates in the transport or sale of a horse previously stabled at a CDI property to a slaughter facility, or to an auction that facilitates sales of horses for slaughter, shall permanently forfeit all stalling and racing privileges at any CDI property.

### 2276. Horseshoes

- (a) Except for full rims 2 millimeters or less from the ground surface of the Horseshoe, traction devices are prohibited on forelimb and hindlimb Horseshoes during racing and training on dirt or synthetic racing tracks.
- (b) Traction devices are prohibited on forelimb and hindlimb Horseshoes during training and racing on the turf.
- (c) Traction devices include but are not limited to rims, toe grabs, bends, jar calks and stickers

## DECLARATIONS AND SCRATCHES

### 305.242 Declarations and scratches.

- A horse may not be considered scratched or declared out of an engagement until the owner or his authorized agent or some person deputed by him has given notice in writing to the racing secretary.
- b. A horse in an overnight race may not be scratched without the approval of the stewards.
- For stake races, if a horse is not named through the entry box at the time designated by the racing secretary, the horse is automatically out.
- d. The declaration or scratch of a horse out of an engagement is irrevocable.
- e. Scratches from stake races will close 45 minutes before post time.
- f. Declaration and scratches from purse races shall be made to the racing secretary by the owner, or his authorized agent at a time which was set by the racing secretary and conspicuously posted.
- g. If the miscarriage of a declaration by mail or otherwise is alleged, satisfactory proof of the miscarriage is required of the complainant; otherwise, the declaration will not be accepted as of the time alleged.

For all medication regulation questions, please refer to the Prohibited Substances list on HISAUS.org.

### Waiver Claiming Rule : Effective 2024

2263. Waiver Claiming Option (a) At time of entry into a Claiming Race an Owner or Responsible Person may opt to declare a Covered Horse ineligible to be claimed, provided: (1) the Covered Horse has not started in 120 days; (2) the Covered Horse's last start must have been for a claiming price; and (3) the Covered Horse is entered in a claiming race with a claiming price equal to or greater than the claiming price for which it last started. (b) A Responsible Person may opt to declare a Covered Horse ineligible to be claimed for a second consecutive race, provided: (1) the waiver must have been asserted in the first race back to be eligible for the second waiver; (2) if the Covered Horse wins the first race back, it is ineligible for the second waiver; (3) if the Covered Horse changes majority ownership subsequent to the first race, it is ineligible for the second waiver: and (4) the provisions in 2263(a)(3) still apply.
